# しゅうがくえんじょ 就学援助制度をご存知ですか?

# School Access Support Fund (Shugaku Enjo Seido)

大田市教育委員会

この制度は、経済的理由によりお子様を小中学校へ就学させることが困難なご家庭に対して、学校でかかる費用の一部を、市が援助するものです。

This is a system that depending on the family's income, the Municipality provides financial assistance for school expenses to guardians who find it difficult to enroll their children in school for financial reasons.

# ■援助を受けることができる方 Who is eligible?

お子様が大田市内の小中学校に通い、世帯が次の認定基準のいずれかに該当する場合受けることができます。援助を受けるためには毎年度申請を行い、教育委員会の認定を受ける必要があります。 Guardians whose children are enrolled in an elementary school or junior high school in Oda city and the household that falls under any of the following items (1) - (3) are eligible.

#### 《認定基準》Criteria

(1) 生活保護を受けている世帯

Household that receives welfare benefits (Seikatsu-Hogo).

(2) 前年度又は当該年度に次のうちいずれかの措置を受けている世帯

Households that received any of the following measures in the previous year or current year.

- a. 生活保護法による保護の停止または廃止
- b. 市県民税の非課税または減免
- c. 固定資産税の減免(地方税法第 367 条)
- d. 国民年金保険料の免除
- e. 国民健康保険料の減免または徴収猶予
- f. 児童扶養手当の受給(児童扶養手当法第4条)
- g. 更正資金(生活福祉資金)の貸付
- a. Household for which welfare benefits have been suspended or abolished (Seikatsu-Hogo).
- b. Household that is entitled to a reduction of or an exemption from Municipal Tax.
- c. Household that is entitled to a reduction of Property Tax.
- d. Household that is exempted from National Pension Premium Payment.
- e. Household that is entitled to a reduction of National Health Insurance Premiums or has been granted postponement of National Health Insurance Premium Payment.
- f. Household that receives a Child Rearing Allowance (Jido-Fuyo-Teate).
- g. Household that get Livelihood Welfare Fund Loan.

# ■受けられる援助の内容 ※児童生徒 I 人あたりの年間援助費(令和6年度基準額のため参考) Provided Financial Support ※Provided amount for each student (Reference Amount)

給食費や校外活動費、修学旅行費などの費用が支給(一部上限あり)されるほか、学用品費や PTA 会費などの費用が定額で支給されます。

This support provides financial assistance for school lunch, outdoor activities, field trip (there are some upper limits), and other related expenses as school supplies and PTA fees.

・認定基準(3)(上記以外で経済的理由によって就学させることが困難であるなど、(1)に準じ

る程度に生活に困窮している世帯)で、所得が生活保護基準額の 1.1~1.2 倍以下の世帯

Other reasons that make difficult to enroll the child in school due to financial difficulty or Households whose income is 1.1 - 1.2 times less than the standard amount of welfare benefits.

#### ■申請方法

#### How to apply?

提出書類を以下の提出期限までに、お子様が通われる学校へ提出してください。所得状況などをもとに審査を行い、審査結果を5月上旬(小学校新 I 年生は3月上旬)にお知らせします。

Submit all the required documents to the school your child is attending by the deadline. After the income screening, the approval will be notified in the beginning of May. (And beginning of March for 1st grade of elementary school students).

#### ■留意事項 Other points of concern

申請書には、同じ家にお住まいの方全員を記入してください。生計を別にしていたり、住民票上は 別の世帯になっていても、同じ家にお住まいであれば生計同一とみなします。

また、単身赴任等で一時的に住民登録が別住所になっている方も生計同一とみなすため、申請書に 記入してください。

Please, fill in all the people who live in the same residence on the application form, even if they don't share the expenses or are in different households on the certificate of the residence (Jyumin-Hyo), if they live in the same house, it will be considered to share the same livelihood.

Also, even if the certificate of the residence is temporary registered in a different city due to job away from home, it will be considered to share the same livelihood, so please fill in the application form as well.
